

# General Terms and Conditions (GTC)

## B&T Shop Range

Version 2026 / 04

### **Purpose**

The shooting range is operated under private law.

### **Legal Form**

The Shooting Range is a service offered by B&T AG, headquartered in Thun.

### **Duty of Care**

Buildings, facilities, and equipment of all kinds must be used with the utmost care. Any damages and its cause must be reported to B&T AG immediately. Costs incurred to repair the damage will be billed to the person responsible. Gross negligence and/or willful damage may result in exclusion.

### **Risk and Liability**

B&T AG does not guarantee continuous supervision of the shooter. This means that you are solely responsible for your actions, safety, and insurance. Entering or using the shooting range involves risks that may result in injury, death, or property damage. You confirm that you agree to assume this risk and liability. B&T AG assumes no liability. In addition, the safety regulations of the shooting range and the posted rules apply. Instructions from staff must be followed in all cases.

### **Registration**

Registration is completed independently via the B&T Range online portal. All required documents must be uploaded there accurately. After uploading, the customer will be contacted to schedule the additional introductory course. After completing the introductory course, the customer will be verified and activated for booking by a B&T employee.

### **Registration of Multiple Persons**

If you make a reservation for multiple persons, you are responsible for ensuring that these persons comply with our Terms and Conditions and fulfill their other contractual obligations.

### **Membership Fee**

The annual fee is CHF 100.00. Membership begins after completion of the introductory course and is automatically renewed for another year unless canceled in a timely manner.

### **Cancellation of Membership**

Cancellation must be submitted via email to [shop@bt-ag.ch](mailto:shop@bt-ag.ch) no later than 1 month before the end of the membership year.

B&T AG reserves the right to admit only a certain amount of people in order to allow active members to shoot regularly in the shooting range.

### **Shooting Skills**

Users who do not have any prior shooting experience may only shoot under the supervision of the B&T AG safety officer at the range. The safety officer will then determine whether independent shooting is permitted. Individuals who present a firearm permit or an official ID card from the police, military, or customs may shoot independently from the start. In any case, a briefing by the safety officer is required before the first use.

### **Video Surveillance**

The entire shooting range, as well as associated premises and their access points, are under video surveillance. The recorded footage is accessed only in the event of a break-in, an assault, property damage, an accident, or theft. The recorded footage is automatically deleted after 30 days at the latest if no incident has occurred.

### **Safety Regulations**

The attached safety regulations are an integral part of the General Terms and Conditions (GTC).

### **Minimum Age**

The shooting range is open to individuals who are at least 18 years of age. Individuals under the age of 18 may only enter the shooting range when accompanied by a parent. The parent is responsible for the child.

### **Persons Not Permitted**

Art. 7 WG and Art. 12 WV – Grounds for exclusion pursuant to WG, Art. 8(2). Persons who, pursuant to the provisions of the Weapons Act (WG) and the Weapons Ordinance (WV), in particular Art. 7 WG, Art. 12 WV, and Art. 8(2) WG, are subject to a disqualifying factor or originate from certain countries that are excluded from shooting activities under applicable legislation, may not participate in shooting.

### **Accompanying Persons**

The customer registered and verified at the Flagship Store is responsible for ensuring that all legal requirements for the participation of their accompanying person are met. They are obligated to ensure and verify that the accompanying person does not originate from the relevant countries or is not subject to any legal grounds for exclusion, as specified in the section “Persons Not Permitted.”

If the accompanying person is a citizen of one of the relevant countries, access to the facility is prohibited. In the event of a violation, we reserve the right to exclude the person from the shooting range.

### **Exclusion**

Users who violate the facility’s Terms and Conditions and safety regulations and/or cause damage may be barred from using the shooting range without a refund of any prepaid fees. Management reserves the right to expel or refuse entry to individuals at the shooting range.

This may be done without providing further reasons.

### **Smoking**

Smoking is strictly prohibited throughout the entire shooting range and its adjacent rooms.

### **Alcohol and Narcotics**

The consumption of any type of intoxicating substance is strictly prohibited. It is prohibited to place oneself in a state in which the shooter endangers themselves or others. It is also prohibited to enter the shooting range while under the influence of medications that impair perception and the ability to make sound judgments or act, or that affect one’s general mental and physical condition.

### **Cartridge cases**

Cartridge cases and any waste generated during shooting must be disposed of in the containers provided after shooting. Taking cartridge cases home is prohibited and is included in the membership fee.

### **Photo/Audio Recordings**

These are permitted throughout the shooting range only with prior approval from the management of B&T AG.

### **System Malfunctions**

If a shooting session must be canceled due to technical reasons or force majeure, customers will receive a refund.
